## **INVITATION TO BID**

## **SUPPLY AND DELIVERY OF ONE (1) UNIT PICK-UP TRUCK**

- 1. The *Murcia Water District (MWD)*, through the *Corporate Budget for the Contract* approved by the Governing Boards intends to apply the sum of **One Million Four** *Hundred Thousand (₱1,400,000.00)* being the ABC to payments under the contract for the *Supply and Delivery of One (1) Unit Brand New Pick-up Truck* with P.R. No. EOM-2022-10-122. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The *Murcia Water District (MWD)* now invites bids for the above Procurement Project. Delivery of the Goods is required *within fifteen (15) calendar days upon receipt of the Notice to Proceed.* Bidders should have completed a contract similar to the Project. - 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from *Murcia Water District Bids* and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below during 8:00 am to 5:00 pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on *October 18, 2022 until November 11, 2022* from the given address and website below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest guidelines issued by the GPPB, in the amount of *Five Thousand Pesos (P5,000.00)*.

- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on *November 07, 2022, 11:00 AM* at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The *Murcia Water District (MWD)* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
