2 PE (SDR-11) (PN-16) Pipes can sustain a nominal pressure (PN) of 1.60 megapascals at 28°C

6 The dimension should be in standard configurations of PE Pipes (SDR-11) (PN-16).

For 160mm (OD) = 14.55mm
For 225mm (OD) = 20.45mm

1 Philippine National Standard Specification for POLYETHYLENE (PE) Pipes (SDR-13.6) for Potable Water Supply (PN12.5) with a nominal outside diameter of 225mm and 160mm intended for the conveyance of potable water under pressure and of temperatures up to 45°C for use below the ground.

2 PE (SDR-13.6) (PN-12.5) Pipes can sustain a nominal pressure (PN) of 1.24 megapascals at 28°C

6 The dimension should be in standard configurations of PE Pipes (SDR-13.6) (PN-12.5).

12 The physical properties shall conform to the physical properties, to with:

Minimum Wall Thickness;
For 160mm (OD) = 11.75mm
For 225mm (OD) = 16.50mm
